### **DOCUMENTS THAT MUST BE ATTACHED**

- a digital photograph of the entire banner, flag or tifo
- a digital photocopy of the identity document
- a digital photocopy of the banner's, flag's or tifo's fire-rating certificate, or at least the technical specifications of the material

### APPLICATION DEADLINES AND ACCESSING THE STADIO BENTEGODI

The authorisation request, together with photos of the banner, the identity document and the banner's fire-rating certificate, must be sent in the manner specified at least seven days before the date of the match. Any changes must be sent within the same timeframe. Applicants declare that they are aware the banner must be brought into the stadium and displayed only in the ways specified in the authorisation.

Authorisation requests received after the above deadlines will not be accepted.

#### FLAGS AND TIFOS

The same documentation must be provided for any flags or tifos.

Please remember that flagpoles must be no longer than 1.5 metres, hollow inside and very flexible. Extendable flagpoles or flagpoles that are longer are forbidden unless expressly authorised, as are umbrellas with metal tips.
