

## **Notice pursuant to art. 13 of European regulation 679/2016 and consent**

Dear SPECTATOR

With this notice, we would like to inform you that to attend the play titled "Natura morta" by Babilonia Teatri you must provide your personal mobile phone number and have the application named Whatsapp installed on that same smartphone.

In this regard, we would like to inform you that the play will include the creation of a broadcast on Whatsapp called "Natura morta", in which all the phone numbers of the spectators attending the performance that evening will be entered. The numbers will be concealed and will not be visible to the other members of the group.

Pursuant to art. 13 of European Regulation (UE) 2016/679 (heretofore GDPR), and in relation to the personal data that our organization will gather when you provide your mobile phone number, we inform you of the following:

### **Data controller responsible for the protection of personal data**

The data controller responsible for processing is La Fondazione La Biennale di Venezia, C.F. and P.Iva 00330320276 headquartered in Venice– San Marco 1364/a – 30124 Venezia.

### **Purposes of personal data processing**

The processing is finalized towards the complete and proper performance of the theatre production that will be staged on the date you have chosen.

The personal data may be processed in ways strictly necessary for the purpose of achieving the aforesaid aims.

We further inform you that the text that will be sent via WhatsApp by Babilonia Teatri, the administrator of the group, is registered for copyright protection with SIAE and any violation of confidentiality will have legal consequences and sanctions.

### **Legal basis for the processing**

The organization of the play processes your personal data lawfully, because the processing:

- is necessary for the performance of the play;
- is based on the express and informed consent that we ask you to give by signing this notice below;

- is necessary to fulfil a legal obligation incumbent on the structure.

### **Consequences of the non-disclosure of personal data**

With regard to the personal data relative to the execution of the performance you have requested or relative to the fulfilment of a legal obligation (for example compliance in the matter of issuing a receipt), the non-disclosure of personal data or non-authorization to process the data will make it impossible to finalize the contractual relationship.

### **Data retention**

Your personal data, which will be processed for the purposes described above, will be retained for the duration of the play's performance and, subsequently, for the time that the organization is obligated to retain it for tax purposes or for other purposes required by law or regulation. All the telephone numbers entered in the Whatsapp group will be removed at the end of the performance by Babilonia Teatri which will be the administrator of the group.

### **Communication of the data**

Your personal data may be communicated to:

1. subjects who process the data to fulfil specific legal obligations;
2. judicial or administrative authorities, to fulfil specific legal obligations.

### **Profiling and disclosure of data**

Your personal data will not be disclosed nor will it be subject to any entirely automated decision-making process, including profiling.

By accepting this notice, you release the Babilonia Teatri company and the organization of the Festival from any liability for the unauthorized disclosure or use of your telephone number entered in the WhatsApp group, made by other spectators during the course of the performance.

### **Data subject's rights**

The rights recognized to you by the GDPR include:

- asking the organization to access your personal data and all information relative to it; the correction of inexact data or the integration of incomplete data; the erasure of personal data that concerns you within the limits set forth in European Regulation 679/2016 (art. 17); limiting the processing of your personal data (in the case of one of the hypotheses listed in art. 18, paragraph 1 of the Regulations);
- to request and obtain from the organization – in the case that the legal basis for the processing is the contract or the consent, and it is done by automated means – your

personal data in a format that is structured and may be read with an automatic device, even with the purpose of disclosing this data to another data controller (a.k.a. right to personal data portability);

- object at any time to the processing of your personal data should any particular situations that concern you arise;
- revoke your consent at any time, limited to the cases in which the processing is based on your consent for one or more specific purposes and concerns common personal data (for example date and place of birth or place of residence), or particular categories of data (for example data that reveals your racial origins, political opinions, religious convictions, health conditions or sexual orientation). The processing based on consent and performed before the revocation in any case remains lawful;
