

INFORMATION ON THE PROCESSING OF PERSONAL DATA pursuant to Article 13 of EU Regulation 2016/679

This information notice supplements the general information notice on the vivaticket.it website

1 - DATA CONTROLLER

2 - PURPOSE OF THE PROCESSING OF PERSONAL DATA AND LEGAL BASIS OF THE DATA PROCESSING (Ref. Art. 6 of EU Regulation 2016/679)

We hereby inform you of the purposes of the collection, storage and processing of your personal data by the Controller:

3 - METHODS OF TREATMENT

The Data Controller also informs you that your data will be processed using paper and manual tools as well as electronic media, in the manner and to the extent necessary to pursue the purposes set out above, in compliance with the principles set out in Article 5 of EU Regulation 2016/679. The data are stored in paper and/or electronic files with full assurance of the adequate security measures required by the New European Regulation 2016/679.

The provision of personal data is optional. However, the Data Controller points out that any refusal to provide your data for purposes 2.1.A., 2.1.B., 2.1.C., 2.1.D. and 2.1.E. will make it impossible for the Data Controller to:

- > provide their services
- > enable the issuing of admission tickets to sporting events
- > assigning neighbouring seats in the stands
- > be involved in the Membership project
- > send you information material
- > be profiled.

4 - DATA RETENTION

The data subject's data will not be disseminated by the Data Controller, who will keep his data for the time necessary to fulfil the stated purposes and also arising from the obligations provided for by law, in any case not beyond the prescriptive terms set for the rights and obligations underlying the processing.

5 - DISCLOSURE OF DATA

The aforementioned data may be processed by authorised data processors specifically appointed by the Data Controller, or by any third parties involved in the processing, appointed as External Data Processors, as they are required to carry out the activities required by contract. The updated list of external Processors is available from the Data Controllers. The Data Processors have been instructed in the matter of security and protection of personal data, with the prohibition, in particular, to disclose or communicate personal data to other third parties, except within the limits of the performance of services. The data may be communicated to the Public Safety or Judicial Authorities where necessary, also for organisational and security purposes related to the event, to the Italian Basketball Federation, to the Basketball League Serie A (more generally to leagues, associations, sports bodies and their sponsors) and to the Control Authorities in fiscal and financial matters for the controls of their competence related to the issue of access tickets to sports events.

6 - TRANSFER OF DATA TO A THIRD COUNTRY

The data collected will be processed within the European Union; in the event of transfer outside the European Union, the Data Controller undertakes to ensure compliance with Articles 44 et seq. of EU Regulation 2016/679.

7 - RIGHTS OF THE INTERESTED PARTIES

You, as a "Data Subject", have specific rights (Art. 12 et seq. EU Regulation 2016/679) as set out below:

- obtain confirmation of the existence or otherwise of personal data concerning you;
- know the content and origin of the data, the purposes and methods of processing;
- verify the accuracy, request the updating and rectification of your data;
- or, when he/she has an interest in doing so, request the integration, cancellation and transformation into anonymous form or the blocking of data processed in violation of the law, including data whose storage is not necessary in relation to the purposes for which the data were collected or subsequently processed.

In particular, you have the right to request data portability. Finally, you have the right to lodge a complaint with a supervisory authority (for Italy, the Garante Privacy).

8 - APPLICABLE LAW
